

In its 60-plus years existence the club has hosted the Colorado State Championship Shoot several times, bringing top trap shooters from all parts of Colorado and neighboring states to Delta County. The club hosts numerous ATA shoots throughout the year and a highly popular annual Labor Day shoot.





# General Shoot Rules



#### Club GENERAL SHOOT RULES

Purses and options are not compulsory.

- ALL EVENTS WILL BE SHOT 5 TARGETS PER POST, 50 PER TRAP (Shoot management reserves the right to modify this format.)
- · Ties for events A, C, 1 & 3 (Singles & Doubles) will be carried over to the next like event.
- Handicap ties will be determined by CSTA officials at the end of each day of shooting. If you do
  not report for shootoffs within the allotted time, you will forfeit. No exceptions to this rule. NO
  CARRY OVERS!
- The CSTA reserves the right to alter or modify the program and to reject anyone who, in our
  opinion is detrimental to the shoot.
- Practice Traps will be open & available @ 7:30am daily. Practice rounds will be \$6.00 per 25 targets. Traps available will be posted near bank assignments along with announced. NOTE: During all CHAMPIONSHIP events practice fields will be limited to UPPER Fields up until first flight of shooters due to all 12 fields will be used during these events. DTC Trap Committee will modify/designate practice fields for the betterment of the shoot at their discretion.
- · Added money is open to all shooters entered in the event.
- (1) It is the responsibility of all special category shooters to ensure they are placed in the correct category at the time they are classified/handicapped. If your special category does not appear on the bulletin sheet, report the omission at the cashier's.
- (2) Class Advance: High Score in each class in Events 1 & 3 will be advanced for all like events. Class advancements will apply independently to in-state and out-of-state classes. PAID OPTIONS FOLLOW SHOOTER TO ADVANCED CLASS.
- (3) 100 or 200 Straight Pins: Shooters breaking 100 or 200 straight without carryover will be awarded a 100 or 200 straight pin. Only one such pin will be awarded to any one individual.
- (4) There will be no co-winners/champions. Ties must be settled for trophies purposes and All American Points.
- (5) Credit cards accepted with a 3% charge for all targets, options and purses



# **Special Categories**



#### SPECIAL CATEGORY SHOOTERS

All Lady I, Lady II, Sub-Juniors, Junior, Junior Gold, Sub Veteran, Veterans, and Senior-Vets must declare their special category at the time of classification in any registered tournament if they wish to compete as a category shooter. Without such declaration, the contestant will not be allowed to compete for the applicable category trophy. No contestant will be allowed to declare or change a special declaration after firing his/her first shot. The only exception to this rule will be to correct an ATA classification error. The following rules apply to shooters who have declared a special category. At all tournaments where All American points will be awarded in any event, shooters may declare only one (1) category (i.e. Lady I, Lady II, Sub-Junior, Junior Gold, Sub-Veteran, Veteran, or Senior Veteran) Note: Chair shooters are exempt from this rule.

- 1. A female shooter, who has not reached her 55th Birthday, may declare Lady I.
- 2. A female shooter, who had reached her 55th Birthday, may declare Lady II.
- 3. A shooter who has not reached his/her 15th Birthday, may declare Sub-Junior.
- 4. A shooter who is 15 but has not reached his/her 18th Birthday may declare as Junior.
- 5. A shooter who is 18 but has not reached his/her 23rd Birthday may declare as Junior Gold.
- 6. A shooter who is 55 but not reached his/her 65th Birthday may declare as a Sub-Veteran.
- 7. A shooter who is 65 but not reached his/her 70th Birthday may declare as a Veteran.
- 8. A shooter who is 70 years of age and older may declare as a Senior Veteran.

9. Age based categories are established on the Birthday of the shooter. For purposes of determining age category for HOA and HAA awards the category declared by the participant of the first day he/she shoots shall be used.

10. Shooters who become eligible for new age based categories during the target year may elect to continue to compete in the previous category for the remainder of that target year. (For example a shooter reaching age 70 may elect to continue to shoot as a Veteran for the remainder of the current target year.) However, once a shooter has elected to move to the new category that decision is irrevocable and he/she may not again declare eligibility for the previous category. Junior shooters reaching the age of 18 may continue to declare Junior category for the remainder of the current target year. Note: Age based special category shooters that are in contention for or desire to achieve All-American Team recognition should review the All-American Team policy in the ATA Rule Book. When there is no Sub-Junior trophy Sub-Juniors will be included in the Junior category. Senior Veterans will be included in the Veteran category when there is no Senior Veteran trophy.

**PETS:** Shooters are required to have their pets leashed at all times while on the grounds. It is also mandatory that you clean up after your pet. Owners will be held liable/responsible for their animals.

**ATVs AND GOLF CARTS:** Use of personal ATVs and golf carts is allowed. Owner must have liability insurance.

#### **CLASSIFICATION**

The Handicap Committee reserves the right to reclassify any shooter at any time during the shoot.

The A.T.A. rules will govern all points that are not otherwise provided. If you win your class or any event or earn yardage in any handicap, it is your responsibility to report such change to the Committee.

Appropriate hearing and eye protection will be worn by all personnel on the firing line; this includes employees who perform duties on or near the trap field.







